# *A note from the Director...*

For our democracy to function we need bi-partisan problems solvers like Sen. Ken Maddy, now more than ever. Creating the next generation of such leaders has always been the driving force behind the Maddy Institute's Legislative Intern Program. It is your support—your investment in our democracy—that makes this program possible.



We have awarded more than 400 legislative intern scholarships since 2001. Our legislative interns have worked in 19 federal and state legislative offices, both Democrat and Republican, in Washington, D.C., Sacramento and throughout the Valley, learning firsthand about how to get things done through the political and legislative process. We would like to provide these opportunities to even more deserving students.

The bottom line is that your investment in our interns has, and will continue to, pay off. In just 15 short years, many of our alumni have already gone on to become Valley leaders in politics, government, law and business. Frankly, that is not surprising given the quality of the students and the rigor of the program (only about 1 in 5 applicants are awarded a Maddy scholarship—and all applicants must have a minimum 3.0 GPA to even apply). The alumni highlighted in this newsletter provide a small example of what our Maddy Alums have done since graduating from the program. As a group, they continue to compile an impressive track record.

We hope you will continue to help us build on that success.
